3. Parents of those students to be called and informed about their behaviour who are often guilty of misconduct or who violate college code of conduct regularly.
4. Issues of sexual harassment and eve-teasing to be reported to the Principal.
5. Adoption of strict anti-ragging code of conduct.

Agenda: Redressal of a grievance received on 26/09/2018 against Zahoor Ahmad Wani.

Date: 26-09-2018

A meeting was held in the staff room on 26/09/2018 under the Convener Grievance Redressal/Internal Complaint Committee to deliberate on the complaint received against Zahoor Ahmad Wani.

It came to the knowledge of College Grievance Redressal/Internal Complaint Committee that the committee has received a complaint from eleven students of the college (names withheld) against a miscreant namely, Zahoor Ahmad Wani; a shopkeeper by profession. The shop of the accused is just outside the college premises. The students of the college had accused Zahoor Ahmad Wani of using abusive language and passing on objectionable comments on regular basis. The College Grievance Redressal/Internal Complaint Committee discussed the course of action to be taken against Zahoor Ahmad Wani. Consequently, it was decided that the complaint would be forwarded to the concerned SHO, who would take the necessary action against the accused.


